Fire Hydrant Water Meter

The following policy has been established by the Board of Directors of the Cross Timbers Water Supply Corporation as the means for Members/Customers to rent a fire hydrant water meter for a limited time period. Members/Customers interested in renting a fire hydrant meter should contact the office of the Cross Timbers Water Supply Corporation.

TERMS AND WATER RATES

- 1) THE AVAILABILITY OF WATER MAY BE LIMITED OR DENIED BY THE CORPORATION AT ANY TIME AND FOR ANY REASON.
- 2) A DEPOSIT OF \$1,800 IS REQUIRED PRIOR TO OBTAINING WATER METER. This deposit amount shall be applied against final bill once meter is returned.
- 3) MONTHLY RATE (Billing Per 30 Days)
\$400.00 Base Service Charge

RATES

001 to 5,000 gal	\$ 3.65 Per 1,000 gal
5,001 to 20,000 gal	\$ 4.70 Per 1,000 gal
20,001 to 40,000 gal	\$ 5.75 Per 1,000 gal
40,001 to 50,000 gal	\$ 8.00 Per 1,000 gal
Over 50,001 gal	\$ 9.00 Per 1,000 gal

- 4) DURING THE TERM OF THIS AGREEMENT, THE MEMBER/CUSTOMER WILL BE REQUIRED TO REMAIN CURRENT ON CHARGES FOR WATER SERVICE HE/SHE IS RECEIVING. **To remain current, the member/customer must pay the billed monthly water charge by the 25th of the following month.**
- 5) LATE PAYMENTS WILL NOT BE PERMITTED. Failure to make a payment at the scheduled time during the term of this agreement will result in the immediate discontinuation of water service (forfeiture of meter).
- 6) DELINQUENT ACCOUNTS WILL BE REFERRED FOR COLLECTION. If a meter is forfeited for non-payment and the account remains unpaid for 45 days from the date of forfeiture, the account shall be referred to collections for non-payment.
- 7) TO RESTORE WATER SERVICE ONCE DISCONTINUED, THE MEMBER/CUSTOMER WILL BE REQUIRED TO:
 - a) Pay the total outstanding balance due without deduction of the Deposit which will thereafter remain on Deposit until the meter is returned and the last statement issued at which time the remaining balance of the Deposit will be applied against the outstanding balance owed.
 - b) Pay all locking and reconnection fees, as set out in the Tariff.
 - c) Pay all cost incurred by the Corporation, including cost of collection, court costs and attorneys' fees.
- 8) THE TARIFF CONTROLS. The terms and conditions set forth herein are a summary of the current Tariff governing Cross Timbers Water Supply Corporation, the full terms and conditions of which are incorporated herein for all purposes. Examination of the Tariff is available upon written request.
- 9) Fire Hydrant water meters will be installed and uninstalled on nearest Fire Hydrant by a CTWS company employee.
